 <u>NOT require transportation* in 2024/2025.</u>

*Transportation to Gillingham is available if you live within one of the following school districts: Blue Mountain, Mahanoy, Minersville, North Schuylkill, Pottsville, Saint Clair, Schuylkill Haven, Shenandoah, or Tamaqua.

If we do not receive both forms completed** by Wednesday, 5/15/2024, then your child's seat will be given to another student on the waiting list and/or your child will not receive transportation next school year.

**There are a few ways to return the 2024/2025 Returning Student Form and Bus Application:

- 1. Complete these 2 forms then return them back to us physically, OR
- 2. Fill electronically: click the link from recent weekly Howler's or on the website's homepage and return to the school via email to enrollment@gillinghamcharterschool.org, OR
- 3. Reach out to enrollment@gillinghamcharterschool.org to have the forms emailed to you to complete and submit them digitally. From there you could return them digitally via email!

Note, <u>ALL FAMILIES</u> will be expected and are required to fill out the Returning Student Paperwork Packet online prior to the beginning of the 2024/2025 school year to verify and/or update any necessary information for you or your student(s).
