## Members of the Board of Trustees Gillingham Charter School

This Summary and Management Report presents information we believe is important to you as members of the school board. We encourage you to review the sections of this report and would be pleased to furnish additional information as requested.

#### 1. Balance Sheet -

- The school's cash balance has decreased slightly from \$972,817 at June 30, 2023 to \$942,354 at August 31, 2023. As of August, the cash balance is equal to 73.3 days of cash on hand.
- Total current liabilities as of August 31, 2023, are \$198,615 lower than at June 30, 2023 which is due to decrease in payroll accrual and an increase in accounts payable. The school continues to be current on all vendor payments.

#### 2. Budget to Actual for the two months ending August 31, 2023 -

- Total School District revenues for the period, at August 31, are \$73,574 lower than budget. The regular education students are coming in 17 lower than budget.
- The budget is based on 194 regular education students and enrollment is currently at 178. The budget is based on 70 sped students and currently there are 69 sped students enrolled.
- At August 31, the total expenditures were \$18,133 higher than the budget. Salaries and Benefits are coming in \$6127 lower than budget. Property services are \$11,179 higher as well as Other Purchase Services by \$15,371.
